Who is your audience?

- They are searching for
 - strong candidate
 - value
- You don't know. Don't you?
 - Find your panel, LS3 (2023)
 - ~74 proposals
 - Step 1: ~57% to select out
 - Step 2: ~63% to select out
 - 13 panellists
 - 4 will read your proposal
 - 22-23 proposals per judge 🤯 🤯
 - They are TIRED
 - Imagine you being a reviewer
 - How would you make your application more attractive?
 - Your mission: one advocate from the panel

Do grant proposal texts matter for funding decisions? A field experiment

Abstract


Scientists and funding agencies invest considerable resources in writing and evaluating grant proposals. But do grant proposal texts noticeably change panel decisions in single blind review? We report on a field experiment conducted by The Dutch Research Council (NWO) in collaboration with the authors in an early-career competition for awards of 800,000 euros of research funding. A random half of panelists were shown a CV and only a one-paragraph summary of the proposed research, while the other half were shown a CV and a full proposal. We find that withholding proposal texts from panelists did not detectibly impact their proposal rankings. This result suggests that the resources devoted to writing and evaluating grant proposals may not have their intended effect of facilitating the selection of the most promising science.

 - <u>Professionals</u>: panelists, ERC winners
 - Non-professionals: important for communicating clearly and effectively, both in writing and in interviews
 - Blue sky, social media, web

How to write a competitive ERC proposal?

MAJOR

- Practice regularly
 - Get grants from your friends / network
- Seek feedback from experts
- Don't be grumpy

Minor

Organize your files to keep track of your progress ("Submitted")

Interview - presentation

- Read the instructions
- Schedule multiple rehearsals and mock interviews with <u>very critical</u> people (with ERC experience). Because you want ERC, you want to be destroyed during the rehearsals not during the interview.
- Huge spectra of questions:
 - Science
 - Publications
 - Budget
 - Team and Hiring
 - Collaborations
 - Equipment
 - Expertise
 - Other grants
 - ...
- Buckle up! (They will be hangry)


Interview - committee

- Who will be in your committee?
 Announced is only the chair
- Do not contact any committee member!
- 2 committees altering every second year
- Every committee member at least 2 times
- Every committee 4 years max
- My prediction


